Councillor Bigelow reported that the Lang Street Project has reached substantial completion, and additional paving was done by Miller on a the corner of Presley Street and Bunker Lane.

6.4 Culture, Tourism & Heritage

Councillor Harrison reported that the Mining Museum Board meeting is scheduled for tomorrow and the Bunker has held it's 2015 AGM.

Councillor Harrison read to Council a letter with which he served notice that he was resigning his position of Chair of Culture, Heritage & Tourism. Letter is attached to these minutes.

Councillor Bigelow requested that Council consider the structural integrity of the Silver Street headframe (Site #5, Silver Trail) as well as requested clarification on the insurance coverage for the Silver Trail.

6.5 Economic Development & Property Management

a) Property Standards Review

Councillor Wuest announced that he is convening a committee to review options for alternative uses for the arena. Councillors Othmer and Nielsen volunteered to be members of the committee.

6.6 Housing & Social Services

Councillor Schwartz reported that the Housing and Social Services Committee hosted the Mini-Putt to raise funds for their initiatives. The mural at the Fraser is now complete thanks to Laura Landers. Weeding is ongoing for the Community Gardens project.

6.7 Recreation

a) Canada Day Report

Councillor Nielsen provided the following report:

Canada Day in Cobalt was another huge success. It is by far the biggest community building exercise the town offers. Thankfully, the weather has never spoiled our event as hundreds of people lined the streets as a light drizzle fell. On behalf of the Cobalt Recreation Committee I'd like to thank the public works crew, the office staff for all their help and the main sponsors, Maria Story of Story Environmental Services, SMC Canada and Dan Cleroux and Wayne Gray at Wayne's Corner Gas, the parade participants and organizers Ruth Ann McDonald and George Othmer. I'd especially like to thank the Cobalt Fire Department for allowing us to host the event at their headquarters each year. We had more than enough food, perhaps next year we will order more hotdogs but we had leftover burgers and enough of everything else. The Kiddies games in the Legion Park were well received and the Legion bands playing inside the fire station was a treat. First Place for the parade floats went to the Seventh Day Adventist Church, Second Place The Bunker Military Museum and Third Palce went to Ashley Moore Charette and her daughter for their decorated quad. BE IT RESOLVED THAT: WHEREAS: the public electricity system in Ontario is a critical asset to the economy and vital to the living standard and well-being of all Ontarians; AND WHEREAS: it is essential that Ontarians maintain public control and public decision-making with respect to the electricity; AND WHEREAS: experience in other jurisdictions shows that privatization typically means consumers pay more for electricity; AND WHEREAS: a privatized Hydro One will no longer be subject to scrutiny by the Auditor General, the Ombudsman, the Financial Accountability Officer, or the Integrity Commissioner, and will no long be required to provide information or services to citizens under the Freedom of Information and Protection of Privacy Act, the Public Sector Salary Disclosure Act, or the French Language Services Act; AND WHEREAS: our public electricity system currently generates hundreds of millions of dollars in revenue for the provincial government every year to help pay for public services we all depend on; AND WHEREAS: the sale of shares in Hydro One will provide a short-term financial gain for the province in exchange for a much larger long-term financial loss; AND WHEREAS: the provincial government has no mandate from voters to sell any part of Hydro One;

AND WHEREAS: opinion polls show Ontarians oppose the privatization of Hydro One by a significant margin in every part of the province; THEREFORE BE IT RESOLVED that the Town of Cobalt call on the provincial government to

- Halt the sale of any part of Hydro One, and maintain Hydro One as a public asset for the benefits of all Ontarians;
- Strengthen Hydro One by investing in the next generation of workers and upgrading our electricity transmission infrastructure;
- Respect the autonomy and local decision-making powers of local distribution companies by not forcing these companies into mergers or sales;

AND BE IT FURTHER RESOLVED: that the Town of Cobalt will communicate this resolution to the Premier, with copies to the Minister of Finance, the Minister of Energy, the area MPP's, and the Association of Municipalities of Ontario (AMO);
