REPORTS, RESOLUTIONS AND DISCUSSION ITEMS PRESENTED BY COUNCIL COMMITTEES

6.1 Mayor's Update

The Mayor reported on the success of the Agnico Luncheon held on June 4, 2015 at which Agnico announced a \$1M donation to the Historic Cobalt Legacy Fund and that Agnico has agreed to make the donation in two instalments rather than the originally set out plan of 10 instalments. The Mayor reported on having attended the Chamber of Commerce Dinner at which local entrepreneur, Connie Boyd, Owner of the Silver Moccasin received the Entrepreneur of the Year Award.

6.2 Finance and Public Safety

Councillor Othmer reported that the Finance Committee has reviewed the user fee by-law and recommended some increases, most notably to the water and sewer rates pursuant to deficits in 2014.

6.3 Public Works and Safety

Councillor Bigelow reported on the following activity for the Public Works Department.:

- Recruitment is underway for the Town's summer students. The posting will close on Friday, June 12, 2015.
- Street sweeping is underway as time permits
- Staff have been responding to a number of emergency sewer line repairs.
- The Public Works Committee has reviewed and submitted a new Waste Management by-law that reflects the new program and the need for tools for enforcement.
- The GIS mapping update project will begin soon. The GPS Unit has been delivered and training provided.
- The Public Works Committee has recommended that the garbage truck and depot recycling bins be declared surplus and the garbage truck be offered to Coleman Township.

Councillor Bigelow expressed concern for the challenge to meet service level standards with current staffing levels. As the summer and fall progresses, the department has a number of project objectives in addition to regular duties. He advised Council to be aware that service levels could be affected as resources are prioritized.

Councillor Othmer reported that he has met with the Canada Day Parade organizer, Ruth-Ann MacDonald, to discuss parade logistics and the role of the Fire Department.
