WHEREAS the Bunker is a tenant in the Fraser Building at an annual rate of \$1; AND WHEREAS the Bunker occupies approximately 25% of the space in Fraser Building; AND WHEREAS the Bunker has access to three (3) water taps; AND WHEREAS natural gas is used to provide both heat and hot water in the Fraser Building; AND WHEREAS the following formula was recently upheld by Council as a fair and equitable distribution of natural gas costs:

WATER TAPS	COUNT	%	SPACE	
Cobalt	24	33%	Cobalt	50%
Co-Tem	45	62%	Co-Tem	25%
Bunker	3	5%	Bunker	25%

### FINAL CALCULATION:

Cobalt = (33% + 50%)/2 = 42.5%Co-Tem = (62%+25%)/2 = 42.5%Bunker = (5+25%)/2 = 15%
