6.1 Chris Oslund - Transit Financial Plan

Mr. Oslund gave presentation on Timiskaming Transit Plan from 2018 to 2028. He noted that the Timiskaming Shores Transit Plan was the smallest in the Province and the cost of a new transit bus is \$500,000. For 2019, users of the transit system can expect a minor fare increase.

6.2 Maria and Anthony Story- Cobalt Constructed Wetlands

Maria Story gave a presentation on the history of the Cobalt Constructed Wetlands and an outline of the work required to bring the wetlands in compliance with the requirements of the Ministry of Environment, Conservation and Parks (MECP). Mayor Othmer suggested that the Minister of MECP be invited to tour the Cobalt Constructed Wetlands and indicated that he would like to see a public open house of the wetlands so Cobalt residents can see how the wetlands operate.

Each of the museum representatives presented a description of their operations and their budget requirements. All indicated that they didn't want to rely on the Legacy Fund to offset their annual operating expenditures and emphasized their importance in attracting visitors the Town. The Classic Theatre indicated they were interested in entering into a long-term lease with the Town to enable them to apply for grants.

Mayor Othmer suggested that Council take a tour of each of the museums in the spring.
