**Being a By-Law to Adopt Amendment No. 3 to the Traffic and Parking By-Law 2021-32 of the Corporation of the Town of Cobalt**

**WHEREAS** the Council of the Corporation of the Town of Cobalt deems it necessary and expedient to pass a By-Law 2021-32 to regulate traffic and parking of vehicles within the Town of Cobalt;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Corporation of the Town of Cobalt hereby enacts as follows:

1. That Amendment No. 3 to the Traffic and Parking By-Law attached hereto and forming part of this By-Law; and
2. That this By-Law shall come into force and take effect on the date of its final passing.

**Amendment No. 1 – Section 5.7 Winter Parking Restrictions – Offence**

Amending Section 5.7, and all relating Appendixes, to amend the Winter Parking Restrictions from “Nov 1<sup>st</sup> in one year to April 15<sup>th</sup> of the next year” to “Nov 1<sup>st</sup> in one year to May 1<sup>st</sup> of the next year “, to correspond with By-Law 2022-28 Winter Operations Plan.

**Amendment No. 2 – Section 5.7 Winter Parking Restrictions – Offence**

Amending Table (B) of Appendix “17” to extend the parking prohibited on Prospect Avenue from “Argentite Street to Silver Street” to “Argentite Street to Westerly Limit at intersection of Prospect Avenue and Jamieson Street South”.

**Amendment No. 3 – Part 5 Section 5.12 Parking Prohibition – Time Limited in Designated Place**

**Add - 5.12.4 Parking Prohibition – Time Limited 120 Minutes – Offence**

Where the Town has erected signs giving notice thereof, no person shall stop, stand, or park a vehicle in locations set out in Table (D) of Appendix “8” for a period exceeding one hundred and twenty (120) minutes at all times, excluding Sundays and Statutory Holidays.

Add Table (D) of Appendix “8”. This section covers the angle parking on the southern side of Prospect in front of the Fraser Building to limit the parking time to 2 hours.
