- 1. Zoning By-Law 2022-24 is amended by rezoning the property municipally known as Argentite Street (Train Station), from the Light Industrial (M1) Zone to the Light Industrial Exception One (M1-1) Zone as shown on Schedule "1" attached to and forming part of this By-Law.
- 2. And further, an exception is added by including the Light Industrial Exception One (M1-1) Zone as section 4.7.3.1, and shall read as follows:

"Light Industrial Exception One (M1-1) Zone:

Notwithstanding the provisions of the Light Industrial (M1) Zone to the contrary, within the Light Industrial Exception One (M1-1) Zone, residential uses, up to 4 dwellings, are permitted uses in the M1-1 Zone. In all other respects the provisions of the M1 Zone shall apply."
